## **Personal data we process**

The World Police & Fire Games Rotterdam 2022 Foundation processes your personal data because you make use of our services and/or because you have provided us with the data yourself.

Below is a summary of the personal data that we process:

- First and last name
- Address details
- Telephone number
- E-mail address
- Visual material

## **Special and/or sensitive personal data we process**

It is not the intention of our website and/or services to collect data about visitors to the website who are younger than 16 years old, unless they have permission from their parent or guardian. However, we cannot check whether a visitor is older than 16. So we recommend that parents get involved in their children's online activities, to prevent data being collected about children without parental permission. ## **The aim and rationale of our processing of personal data**

- Informing you about changes to our products and services

## **No automated decision-making**

The World Police & Fire Games Rotterdam 2022 Foundation does not take decisions based on automated processing on matters that could have consequences (significant or otherwise)

for people. This relates to decisions taken by computer programs or systems, without a person being involved (for instance, a World Police and Fire Games employee).

### **How long we hold personal data**

The World Police & Fire Games Rotterdam 2022 Foundation does not hold your personal data any longer than strictly necessary to realize the objectives for which your data is collected. Your data is not held for longer than a year if no agreement has been reached with you.

### **Sharing personal data with third parties**

The World Police & Fire Games Rotterdam 2022 Foundation only provides data to third parties if it is necessary for fulfilling our agreement with you or to comply with a statutory obligation.

### **Cookies, or similar techniques, which we use**

The World Police & Fire Games Rotterdam 2022 Foundation uses analytical, technical and functional cookies. A cookie is a small text file that is saved to your computer, tablet or smartphone the first time you visit this website. On the website of the World Police & Fire Games Rotterdam 2022 Foundation, general data is kept about the visit, including the IP address of your computer and the time of retrieval, and data that your browser sends. This data is used to analyze visit and click behavior on the website. The World Police & Fire Games Rotterdam 2022 Foundation uses this information to improve the functioning of the website. The data is anonymized as much as possible and is not shared with third parties.

### ***Google Analytics***

The World Police & Fire Games Rotterdam 2022 Foundation uses Google Analytics to record how visitors use the website. The information obtained in this way, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States. The World Police & Fire Games Rotterdam 2022 Foundation has not given Google permission to use Analytics information obtained via the World Police & Fire Games Rotterdam 2022 Foundation for other Google services.

You can opt out of cookies by setting up your internet browser in such a way that it no longer saves cookies. In addition, you can delete all information saved earlier via the settings of your browser.

### **Social Media**

### **Viewing, amending or removing data**

This means that you can submit a request to us to transfer the personal data we hold about you in a computer file to yourself or to another organization you name.

In order to ensure that the request to view the data has been submitted by you personally, we will ask you to send a copy of your identity document with your request. In this copy, please blacken out your passport photo, MRZ (machine readable zone, the strip containing numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as quickly as possible, but at any rate within four weeks.
